PRIVACY POLICY

The following document establishes the regulations regarding privacy policies of www.sportsocialmarket.com (hereinafter, "the website"), for which the trading company SPORT SOCIAL MARKET S.L.. (hereinafter, SPORT SOCIAL MARKET) is responsible, with registered address in C/ d'Aribau 195, 1º izq., 08021, Barcelona and holder of Spanish tax identification number B-66853755.

PRIVACY POLICY

SPORT SOCIAL MARKET has particular interest in preserving, safeguarding and guaranteeing any personal data provided by the websites users and, we do so as set in the information regarding data processing stated herein.

SPORT SOCIAL MARKET reserves the right to modify the Privacy policy stated herein, in order to adjust it to any legal or judicial updates. In the given case, all implemented changes shall be communicated on said website within reasonable time in advance before its entry into force. This implies that, after communication to users of the modification, users acknowledge and give tacit acceptance of said modification when using the services provided by the web page.

INFORMATION COLLECTED

When a user registers for the website with an account, to later operate on said site, the information will be collected and stored for administrative reasons and for services related to the website. Among the users collected and required data to correctly carry out their registration and use of the site there is personal data (such as their full name, address, date of birth, telephone number and e-mail address) and financial information, which will be collected upon payment of the products offered to the user by the website.

APPLICABLE LEGISLATION

The following site complies with the regulations on handling of users' personal data as set by the existing legislation and adopts the corresponding technical and organizational measures to avoid loss, misuse, alteration, unauthorized access and theft of the provided personal data, bearing in mind advanced technology available, the nature of the data and the risks to which they are exposed, as well as guarantee of the ARCO rights (acceptance, rectification, cancellation or opposition).

SAFETY

To have access to the services of the website that require registry, a personal password must be selected. Thus, the corresponding user shall be the sole responsible for safekeeping the confidentiality of said password, as well as of any activities taking place during the operability of the session under said user name and password.

The user agrees to notify SPORT SOCIAL MARKET, as soon as possible, of any unauthorized use of their user name and password, as well as of any security breaches.

Under no circumstances shall SPORT SOCIAL MARKET be held responsible for the damages or losses resulting from the user's breach of mentioned obligation.

DATA COLLECTION

In order to use the services promoted by www.sportsocialmarket.com the user must be appropriately identified, which means that the user must provide all the required data correctly and truthfully to correctly provide the services. Participating in the website's activities requires the user to identify themselves by registering and creating an account, including a user's name and password given after completing the corresponding registration form.

The user's data shall be handled in aims to answer to the user's requests regarding the services provided by the website. SPORT SOCIAL MARKET shall only handle data provided by the user by means of said forms, as well as any other information gathered after the fact, in order to comply with the established objectives as stated by the user.

Provided data shall be included to a personal data file, as provided in the Privacy Policy, and will be duly registered. Communication of personal data implies the user's express acceptance of its incorporation in the corresponding files.

Lack of communication, or incomplete communication of required data, shall imply the inability to provide services. SPORT SOCIAL MARKET shall use any personal data to provide Services by means of the www.sportsocialmarket.com website and, when expressly stated by checking the box under "E-mail notification" in the account Settings, to receive notifications related to variations in their community shares.

VERACITY OF INFORMATION

In order to participate in SPORT SOCIAL MARKET's website, the personal data provided by the user must be accurate and current. Participation shall not be authorized if the user does not fully complete the required information in each field of the given registration form of

www.sportsocialmarket.com or if the user does not complete all fields, as established in the Service Conditions.

Should SPORT SOCIAL MARKET have any indicatives that the data provided by the user is untruthful or is pending to complete required information, it reserves the right to request additional information or ratification of said information through the contact means provided by the user in the corresponding account or form.

Thus, the user shall be solely liable for the veracity of the data provided, therefore forbidding identity theft or providing personal data to a third party without prior express authorization. If SPORT SOCIAL MARKET should learn about identity theft activities, the user will be disabled from the website and the corresponding legal procedures shall be applied.

DATA MODIFICATION OR CANCELLATION

IP ADDRESSES AND COOKIES

Registry of said IP address serves exclusively for internal matters. GENERAL INFORMATION OF THE COOKIES POLICY
